## The organization's objectives:

- 1- To raise awareness among youths in different sciences as well as cultures by holding awareness symposiums and training courses which are beneficial to individuals and serve our society once got qualified on our programmes.
- 2- To work on enhancing the role of woman in all fields of development in the society and to benefit from her abilities through courses and programs that are adopted by the organization.
- 3- To provide legal defence means by the organization legal work team which consist of a group of lawyers for those who are in prison for being accused of many offenses before prosecutions and courts and other official entities and to pursue their release after punishment period finished as well as to rehabilitate and reintegrate them in the society.
- 4- To enhance the principles of rights and public freedoms and to protect them from violations, along with civil society organizations working in the field.
- 5- To contribute in implementing relief programs for displaced people due to natural disasters and wars and relief programs that are approved by international refugees agencies/organizations from outside the country according to applicable regulations.
- 6- To convey youths opinions and suggestions of their different life interests to executive and legislative entities in order to be considered upon issuing legislations and executive decisions.

- 7- To adopt youth camps for programs which link youth of different governorates and to exchange experiences and skills in the fields for which the organization established in order to benefit all the society personals.
- 8- Contribution in financial and administrative corruption control programs by contacting with concerned authorities/entities and bodies; and integration of efforts programs implementation, as well as, contribution in enacting laws and regulations with assistance of executive authority to be presented to the parliament and competent committees.
- 9- To control illiteracy by supporting families who are unable to educate their children in schools and technical institutes.
- 10-To provide support for orphans, widows, poor people and handicapped to be able to benefit from preparation and training programs that are implemented by the organization.
- 11-To provide support for people with chronic and incurable diseases and to help reduce medication costs and drugs prices.
- 12-To combat smoking and Qat chewing through holding scientific symposiums and hosting a number of experts in those two fields to clarify health, economic and environmental damages and the effect of widespread planting Qat in a way on groundwater reservoir and areas that are suitable for planting vegetables and fruits and to raise awareness with the importance of agricultural cooperatives in marketing and keeping products.
- 13-To contribute in the limitation of unemployment by preparing database and information system regarding unemployed abilities and skills and different education graduates and available opportunities with public and private sectors by coordinating with concerned entities such as labour office in governorates.
